In my current position, I am responsible for two tasks that support the ODNI and several tasks that focus on cyber operations. As part of my work on the USSTRATCOM SAG, I also recently chaired a Nuclear Command and Control (NC2) review in support of the NSA Advisory Board.

Upon being notified of my error, I paid all required taxes and interest, including \$2,133 to the IRS and \$156 to Virginia.

In 2004 and 2005, I was informed by the IRS and the Virginia Department of Taxation that I owed back taxes and interest on my 2002 tax returns. The tax authorities believed that I had failed to report the value of my company car as compensation in 2002. This issue stemmed from a paperwork oversight on the part of my employer, TRW, Inc. — I had purchased my company car from TRW in 2001, but in 2004, after Northrop Grumman purchased TRW, Northrop reported the car to the IRS. Nevertheless, upon receiving notifications from the IRS and Virginia, I paid all required taxes and interest, including a total of \$2,563 to the IRS and \$1,904 to Virginia.

Congress provides two important functions --- they make the laws and provide oversight. Congressional oversight of the Intelligence Community is conducted primarily through the two intelligence committees. This oversight serves a number of important functions including, among other things, making sure that intelligence activities

comply with the Constitution and our laws, including the protection of privacy and civil liberties, and ensuring that the Intelligence Community operates effectively and efficiently in fulfilling its mission and maintaining the security of our nation. The Director of National Intelligence's basic obligations concerning the intelligence oversight process are found in Section 502 of the National Security Act of 1947, which requires the DNI to keep the two intelligence committees "fully and currently informed" of all U.S. intelligence activities (excepting covert actions that are covered in Section 503), including "significant anticipated intelligence activities" and "significant intelligence failures."

49. EXPLAIN YOUR UNDERSTANDING OF THE RESPONSIBILITIES OF THE CHIEF INFORMATION OFFICER OF THE INTELLIGENCE COMMUNITY.

The DNI has broad statutory authorities and responsibilities, some exercised through the Chief Information Officer of the Intelligence Community, for the development of an integrated, interoperable and interdependent information technology infrastructure across the intelligence community enterprise. The DNI has principal authority for intelligence information sharing, and to ensure maximum availability of and access to intelligence information within the intelligence community consistent with national security requirements. In the exercise of this statutory responsibility, the DNI is charged by law with the duty to establish common information technology standards, protocols and interfaces across the intelligence community, to ensure the development of information technology systems that include multi-level security and intelligence integration capabilities, and to develop an enterprise architecture for the intelligence community. The DNI is also responsible for ensuring that elements of the intelligence community comply with that architecture. In support of these efforts, the IC CIO, under the direction of the DNI, has a statutory responsibility to direct and manage all information technology related procurement for the intelligence community, and to manage activities relating to the information technology infrastructure and enterprise architecture requirements of the intelligence community. The IC CIO also has procurement approval authority over all information technology-related procurement for the intelligence community, and is responsible to ensure that all expenditures for information technology and research and development activities are consistent with the intelligence community enterprise architecture and the strategy of the DNI for such architecture.

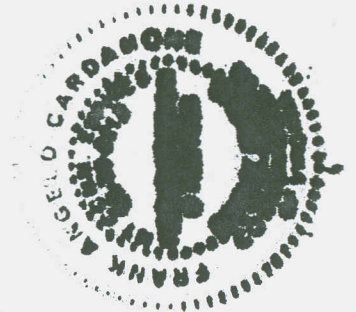

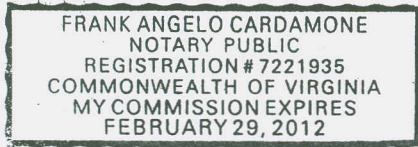


